Thank you for your interest in the Pratt Music Scholarships.

The Pratt Music Foundation was established to promote music education, with an emphasis on classical strings and piano, in the Bloomington-Normal area. The generous support of donors in the community allows us to grant music scholarships to elementary and secondary school students in the Bloomington-Normal area.

The recipient of a Pratt Music Scholarship is provided tuition for an academic year (including summer) of instruction in piano or strings at the **Illinois Wesleyan University Music Preparatory Program**, conducted on the campus of Illinois Wesleyan University in Bloomington. Instruction consists of individual weekly lessons.

Award Criteria. Scholarships are awarded based on financial need, talent, and motivation. While most scholarships are awarded to students who have already had some instruction, students with no musical experience are also considered.

Eligibility. Any student in grades K through 12 and capable of regularly attending instruction will be considered. As a practical matter, most students are drawn from the Bloomington-Normal area.

Acceptance To The Prep Program. Scholarships are awarded contingent on the student's acceptance into the Prep Program (that is, scholarship students must apply to, and be accepted into, the Prep Program).

PRATT SCHOLARSHIPS INCOME GUIDELINES

Pratt Music Scholarships are granted based on talent and financial need.

The scholarship guideline for income is 250% of HHS Poverty Guidelines.

The information provided in the application allows the computation of an adjusted income which must be equal to or less than 250% of the HHS Poverty Guidelines.

Income is stated income less any unusual expenses stated (medical, catastrophic, etc).

For example, a family of 3 with an income of \$42,000 is less than the maximum guideline income (in the 250% column) of \$46,325, and is eligible for consideration.

This guideline changes as the Federal Poverty Guideline changes.

Department of Health and Human Services (HHS) 2011 POVERTY GUIDELINES

There are two slightly different versions of the federal poverty measure: the poverty thresholds, and the poverty guidelines.

The poverty thresholds are the original version of the federal poverty measure. The thresholds are used mainly for statistical purposes — for instance, preparing estimates of the number of Americans in poverty each year.

The poverty guidelines are the other version of the federal poverty measure. They are issued each year by the Department of Health and Human Services (HHS). The guidelines are a simplification of the poverty thresholds for use for administrative purposes — for instance, determining financial eligibility for certain federal programs.

Programs using the guidelines (or percentage multiples of the guidelines — for instance, 125 percent or 185 percent of the guidelines) in determining eligibility include Head Start, the Food Stamp Program, the National School Lunch Program, the Low-Income Home Energy Assistance Program, and the Children’s Health Insurance Program. Note that in general, cash public assistance programs (Temporary Assistance for Needy Families and Supplemental Security Income) do NOT use the poverty guidelines in determining eligibility. The Earned Income Tax Credit program also does NOT use the poverty guidelines to determine eligibility.

The poverty guidelines (unlike the poverty thresholds) are designated by the year in which they are issued. For instance, the guidelines issued in January 2011 are designated the 2011 poverty guidelines. However, the 2011 HHS poverty guidelines only reflect price changes through calendar year 2010; accordingly, they are approximately equal to the Census Bureau poverty thresholds for calendar year 2011.

The poverty guidelines may be formally referenced as “the poverty guidelines updated periodically in the Federal Register by the U.S. Department of Health and Human Services under the authority of 42 U.S.C. 9902(2).”
